**MOTION TO PERMIT ELECTRONIC SERVICE**

Northern Pass Transmission LLC and Public Service Company of New Hampshire d/b/a Eversource Energy (the “Appellants”), hereby request that the Court allow for electronic service of their Notice of Appeal and Appendix filed herewith. As grounds for this motion, the Appellants state as follows:

1. In the proceedings before the Site Evaluation Committee (“SEC”) in this matter, more than one hundred individuals or entities were either parties, or sought intervention and were granted the status of intervening parties. As a result, preparing hard copies of the Notice of Appeal and Appendix would result in a substantial expense.

2. At the SEC, all parties and intervenors were served by electronic service through the SEC website. The service list used by the SEC for this purpose (with the exception of “Interested Parties,” who were neither parties nor intervenors at the SEC), is attached to the Notice of Appeal filed at the same time as this motion.

3. The Appellants intend to provide, and contemporaneously with the filing of this Motion, will have provided, service of the Notice of Appeal by electronic service and

the Appendix by a “share file” through which all of the parties and intervenors will have access to the Appendix.

4. The SEC, and Counsel for the Public, Christopher Aslin, Assistant Attorney General, have consented to electronic service. See Supreme Court Rule 10(7).

WHEREFORE, the Appellants respectfully request that the Court enter an order:

- (A) Permitting the service of the Appellants’ Notice of Appeal by electronic service and of the Appendix to the Notice by share file; and
- (B) Granting such further relief as may be just, equitable and appropriate.


